Calne Without Parish Council 14th December 2020 Agenda Item Calne Community Area Transport Group (CATG)

1 Introduction

The Calne CATG met on 26th November 2020, minutes to be presented to the next available Area Board. A spreadsheet with all projects has been circulated.

2 Current projects

2.1 Lower Compton 40mph Speed Limit and Clearway

The orders have been issued and the plan for the signage provision is being formulated. The painting of the yellow lines will be delayed until the Spring for practical reasons.

2.2 Church Road Derry Hill

The Experimental Order for the Waiting restriction were put in place on 24th August and Wiltshire Council has not received any representations so far. A period of 6 months is set for any representation to be submitted.

2.3 Church Road Derry Hill Community Speed Watch

The Council has 6 residents that have shown an interest in setting up a Community Speed Watch Team for Church Road in Derry Hill. The police Community Speed Watch Coordinator has provided forms for the interested residents to fill in and, subject to sufficient numbers, will progress to provide training when the Covid-19 situation and workload allow.

2.4 Highways response to Covid-19 Reallocation of Road Space: 8.A4 Black Dog Bridge to A3102Greenacres Way – shared use path

Cllr Jones reported to CATG that the Parish Council did not consider this a high priority and did not request that it is progressed.

3 Calne Area Transport Strategy

The Transport Strategy Group are still waiting for the revised final draft of the Transport Strategy from Wiltshire Council. Atkins had been asked to go back and relook at some of the figures used in the final draft before publication.
